Give the completed affidavit of support with all required documentation to the sponsored immigrant to file with either: a Consular Officer with a completed Form OF-230, Application for Immigrant Visa and Alien Registration, or an Immigration Officer with a completed Form I-485, Application to Register Permanent Residence or Adjust Status
