Those familiar with what the DBQ entails might also know that you're welcome to choose whatever argument you want — as long as you can support it.

### 3 Tips for the AP U.S. History Document-Based Question ...

The document-based question measures your ability to analyze and synthesize historical data and to assess verbal, quantitative, or visual materials as historical evidence. As with the long essay, responses to the document-based question will be judged on your ability to formulate a thesis and support it with relevant evidence.

The DBQ requires you to analyze the documents in addition to bringing outside information to bear on the question.
