The US Court of Appeals for the Seventh Circuit in Chicago ruled Friday afternoon that the clergy housing allowance is a constitutionally permissible tax benefit.. The Seventh Circuit reversed a 2017 decision by a federal district judge in Wisconsin, which favored leaders of the tax-exempt atheist organization Freedom From Religion Foundation (FFRF).
