Many Supreme Court observers, including no less than Justice Samuel Alito himself, have described *Maryland v. King* 1 as perhaps the most important criminal procedure case that the Court has decided in decades. 2 While this may well be true, the question presented to the Court was actually quite simple: Is the warrantless collection of DNA from arrestees unreasonable under the Fourth Amendment?

Appellate brief. An appellate brief is a written legal argument presented to an appellate court. Its purpose is to persuade the higher court to uphold or reverse the trial court's decision. Briefs of this kind are therefore geared to presenting the issues involved in the case from the perspective of one side only.
