Documentation of informed consent is an important aspect of regional anesthesia practice. Practice patterns vary widely on this issue, and specific written consent for nerve block procedures is often not obtained.

### **Equipment for Regional Anesthesia - NYSORA**

If regional anesthesia was attempted but unsuccessful, select "2". If regional anesthesia was not performed or attempted, select "3" even if there is documentation of a reason why it was not performed or attempted.

### **Regional Anesthesia (v2019A) - manual.jointcommission.org**

If reasons are not mentioned in the context of anesthesia, do not make inferences (e.g., do not assume that regional anesthesia was not used because of a bleeding disorder unless documentation explicitly states so). Example: "Bleeding disorder", review the chart for documentation about reason why regional anesthesia was not used or attempted.

### **Reason for No Regional Anesthesia (v2019A)**

Our audit showed that the quality of documentation of consent for regional anaesthesia has significantly improved throughout the trust since the introduction of the regional consent stickers. Future improvements could be achieved by having the consent stickers printed into the Anaesthetic charts.

1. Determine the appropriate CPT® code(s) for the surgical procedure(s) performed. 2. Crosswalk the CPT® code(s) to the appropriate ASA code. 3. Determine the appropriate number of base units. 4. Determine the appropriate number of time units. 5. Assign the appropriate modifier to identify the anesthesia provider.
