Family Child Care Home Law. Legislation (SC Statute 63-13-825 A and SC Statute 63-13-830 E) was passed June 9, 2016, to increase the number of training hours required for family child care home providers, from two hours to TEN (10) hours. Additionally, this legislation states if the training is not completed, it could affect the status of a provider's registration or license.
