In this instance Temporary would mean for a limited time (normally not exceeding 30 days) and Guardian denoting a person lawfully invested with the power to take care of and manage the property and rights of a person (such as a minor).

Free Temporary Guardianship Form - Free Legal Documents

The guardianship papers must be filed with the court and a hearing date will be set. The relatives of the child (usually the parents) must be served with a notice of hearing. The child and the nominated guardians must appear for the hearing. If guardianship is granted, there are other forms that must be completed.
