Maximize your IRA contributions. You have until the April 15th filing deadline (unless delayed due to a weekend or holiday) to open a traditional IRA for the previous tax year. That gives you the flexibility of claiming the credit on your return, filing early and using your refund to open the account.

You have to file a tax return claiming your refund amount. You must file that tax return within three years of the original due date of the return. That last point is an important one.

Don't take the standard deduction if you can itemize. The standard tax deduction (\$6,350 for singles and \$12,700 if you're married filing jointly in 2017) is a deduction set by the IRS that allows you to reduce your taxable income if you cannot take advantage of more tax deductions by itemizing.
