Skilled Physical Therapy Application of Guidelines. Range of Motion (Cont.) Range of motion exercises which are not related to the restoration of a specific loss of function often may be provided safely by supportive personnel, such as aides or nursing personnel, and may not require the skills of a physical therapist.
