### **RESCINDING AN IN ABSENTIA ORDER OF REMOVAL**

When to File a Motion to Reopen an Immigration Matter. If you file a motion to reopen your case, that motion should: assert new material facts that were not known or available before, and present affidavits and/or other documentary evidence to support those facts.

### **Immigration Case Denials: Motions to Reopen and Reconsider**

A motion to reopen allows an immigrant who loses his or her case in immigration court to present new or changed facts to the immigration judge. The motion to reopen must state the new facts that will be proven at a hearing if the motion is granted. The facts must be supported by affidavits or other evidentiary material.2.

### **How to Bring a Motion to Reopen a Case in Immigration Court**

required to personally attend all hearings in Immigration Court and if you fail to do so, the Immigration Judge will enter an order of removal or deportation as a consequence.
