The Precise Neurological Exam

All patients with a neurological complaint including headache, weakness, dizziness, lightheadedness, etc., must have a thorough neurological exam documented. It is okay to note that a patient is not being cooperative with a neurological exam and to document what you are actually able to witness during your initial assessment .

Sample Normal Exam Documentation Documenting a normal exam of the head, eyes, ears, nose and throat should look something along the lines of the following: Head - The head is normocephalic and atraumatic without tenderness, visible or palpable masses, depressions, or scarring. Hair is of normal texture and evenly distributed.

The Neuro-Psychiatric Exam is comprised of two parts- the written and the personal interview.
