All taxpayers who received more than \$33 in total gross taxable income in calendar year 2016 must file a Pennsylvania personal income tax return by midnight, Tuesday, April 18, 2017.

You can also write the last four digits of your Social Security number, "2016 PA-V", and daytime telephone number on your check or money order. If you are filing a joint return, enter the last four digits of the SSN shown first on your return. The department will need the last four digits of your SSN to accurately apply your payment.
