In order for nonprofit organizations recognized as tax exempt to maintain tax-exempt status and avoid penalties, there are certain activities that are prohibited, and certain filing and disclosures required: Prohibited Activities Private benefit and inurement – a public charity (organized as 501(c)(3)) and many types of non-501(c)(3) tax-exempt organizations are prohibited from allowing inurement of net earnings or assets of the organization to benefit any insider.
